 Environmental Foreman from Precision walked with the EI on his inspection. Inspected ECDs were found to be in compliance

- The EI observed that the contractor has worked in the inspection area since the last inspection and performed routine
 maintenance on electric livestock fencing.

Two issues were submitted for the punch list which consisted of two locations where perimeter CFS had been damaged by third party traffic. The contractor patched the CFS immediately. Other inspected ECDs were found to be in compliance at the time of inspection. The EI did not observe that the contractor has worked in the inspection area since the last inspection. There have been no rain events in the inspection area since the last SWPPP inspection. The ROW ground condition is dry. 									
 At the time of inspection permanent vegetative stabilization was adequately established to inhibit erosion from 13900+00 to 13910+00 and from 13921+00 to 13940+00. At the time of inspection temporary vegetative stabilization was adequately established to inhibit erosion.




